# GPA submits comments to U.S. Fish and Wildlife on Northern Long-Eared Bat

GPA's Natural Resources Subcommittee has submitted comments to the U.S. Fish and Wildlife Service (USFWS) addressing concerns of listing the Northern Long-Eared (NLE) Bat as either an endangered or threatened species. Led by committee Vice Chair Jimmie Hammontree, Access Midstream, GPA acknowledges support to the USFWS efforts to protect threatened and endangered species when there is sound scientific justification for such a listing. However, with the NLE Bat, legitimate concerns have been expressed by many in the scientific community, state and federal agencies, and members of Congress stating that the USFWS is not using the best available scientific methods or data to justify its proposed listing decision. GPA requested that the USFWS strongly consider the following points when making its listing decision:

- The hibernacula counts used by the USFWS have not generated an accurate portrayal of NLE Bat populations.
- The USFWS stated in its June 30 Federal Register notice that there is substantial scientific uncertainty and disagreement about the analysis and interpretation of how white-nose syndrome (WNS) will spread and affect the bat population.
- Improving research on WNS and identifying solutions to reduce or eliminate its effect on the NLE Bat should be the preliminary focus at this time.
- Should the USFWS proceed with anything other than a "not warranted" listing, GPA respectfully requests that the USFWS issue a "threatened" listing and also promulgate a 4(d) rule to allow activities that are not detrimental to the NLE Bat populations to continue and to create a mechanism to fund additional research on WNS and monitor the success of overall conservation measures.

Our Natural Resources Subcommittee will continue to work with USFWS, and others, to prevent unjust classifications that would hinder midstream operations.

## GPA & GPSA board meeting dates to change for 2015

The timing of board meetings will change in 2015 from the traditional April, June and October meetings. # 8th International Petroleum Technology Conference

GPA is a senior endorsing organization of the 8th International Petroleum Technology Conference (IPTC) that will be held Dec. 10-12.

IPTC is an annual event rotating between Asia Pacific and the Middle East. IPTC is organized to further the advancement of scientific and technological knowledge related to the exploration, development, production, transportation and processing of oil and natural gas. The conference program will be focused on dissemination of new and current technology, best practices and multi-disciplinary activities designed to emphasize the importance of the "value chain" and maximizing asset value. The knowledge, capabilities, and strengths of the participating countries and the sponsoring societies' global membership, over the spectrum of multi-disciplinary technologies, will be central to the success of the conference and the corresponding exhibition.

The IPTC is a collaborative effort among the American Association of Petroleum Geologists, the European Association of Geoscientists and Engineers, the Society of Exploration Geophysicists, and the Society of Petroleum Engineers.

The conference is set to take place at the Kuala Lumpur Convention Centre, returning to Malaysia for the first time since 2008. Recent past events have been held in Doha, Bangkok and Beijing.

# Form EIA-915 Update

A GPA ad hoc task force continues working with the Energy Information Administration (EIA) on proposed Form EIA-915 (Monthly Gas Processing and Liquids Report). EIA collects three types of data – public, confidential and Confidential Information Protection and Statistical Efficiency Act (CIPSEA). CIPSEA-protected data is the highest level of confidential data EIA collects and is only used for statistical purposes. GPA strongly believes that Form EIA-915 should be provided CIPSEA protection, which would alleviate many of the issues that GPA members have with the data collection/dissemination concerning Form EIA-915.

The latest activity includes GPA providing two edited versions of Form EIA-915 for EIA's consideration. One version would contain the data GPA feels gas processors can provide if CIPSEA would apply. The second version would illustrate the data GPA feels gas processors can provide if CIPSEA would not apply. GPA representatives are scheduled to meet with EIA next week in Washington, D.C., to further this discussion.

Preserving the ongoing confidentiality of the foregoing information is critical to maintain a level playing field in the highly competitive midstream sector of the oil and gas business. GPA and its members remain committed to the cooperative relationship we have enjoyed with the EIA and will continue dialogue on issues concerning Form EIA-915.

## **ASTM Natural Gasoline Specification to be balloted**

ASTM Subcommittee D02.A0 has submitted Work Item WK45419 – *Specification For Natural Gasoline as a Blendstock in Ethanol Fuel Blends or as a Denaturant for Fuel Ethanol* to the balloting committee, and results of the vote will be noted at the D02-H Liquefied Petroleum Gas meeting in December. The subcommittee expects the ballot to pass with no negative votes. The Environmental Protection Agency has expressed concern over the current sulfur limits. The current U.S. sulfur limit for denatured fuel ethanol is 30 ppm. Effective Jan. 1, 2017, the sulfur limit for denatured fuel ethanol will be 10 ppm [40 CFR 80.385 (e)(2)] and the sulfur limit for certified denaturants will be 330 ppm [40 CFR 80.1611 (a)(1)].

### **GPA 2377 published**

GPA Technical Section B – Analysis & Test Methods has completed all revisions to GPA Standard 2377-14 – *Test for Hydrogen Sulfide and Carbon dioxide in Natural Gas Using Length of Stain Tubes*, and it is available for purchase in the GPA Publications area on our web site.

The standard covers the determination of the concentration of  $H_2S$  and  $CO_2$  in natural gas using a length of stain tube. The range covered is 3 ppmv to 5% by volume  $H_2S$  and 0.25 to 10% by volume of  $CO_2$ . The method as written is applicable to the determination of  $H_2S$  and  $CO_2$  in hydrocarbons and in air.
